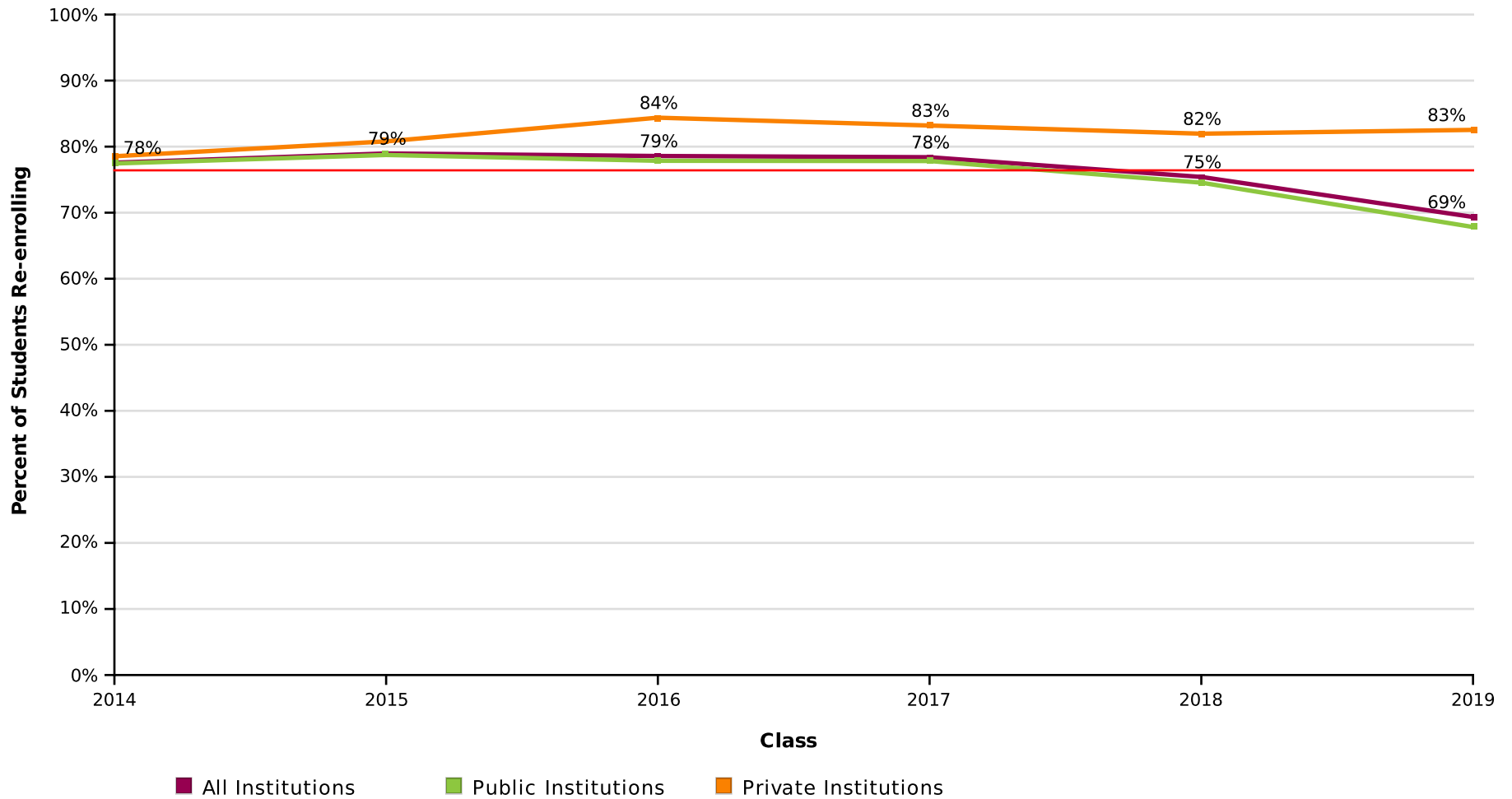

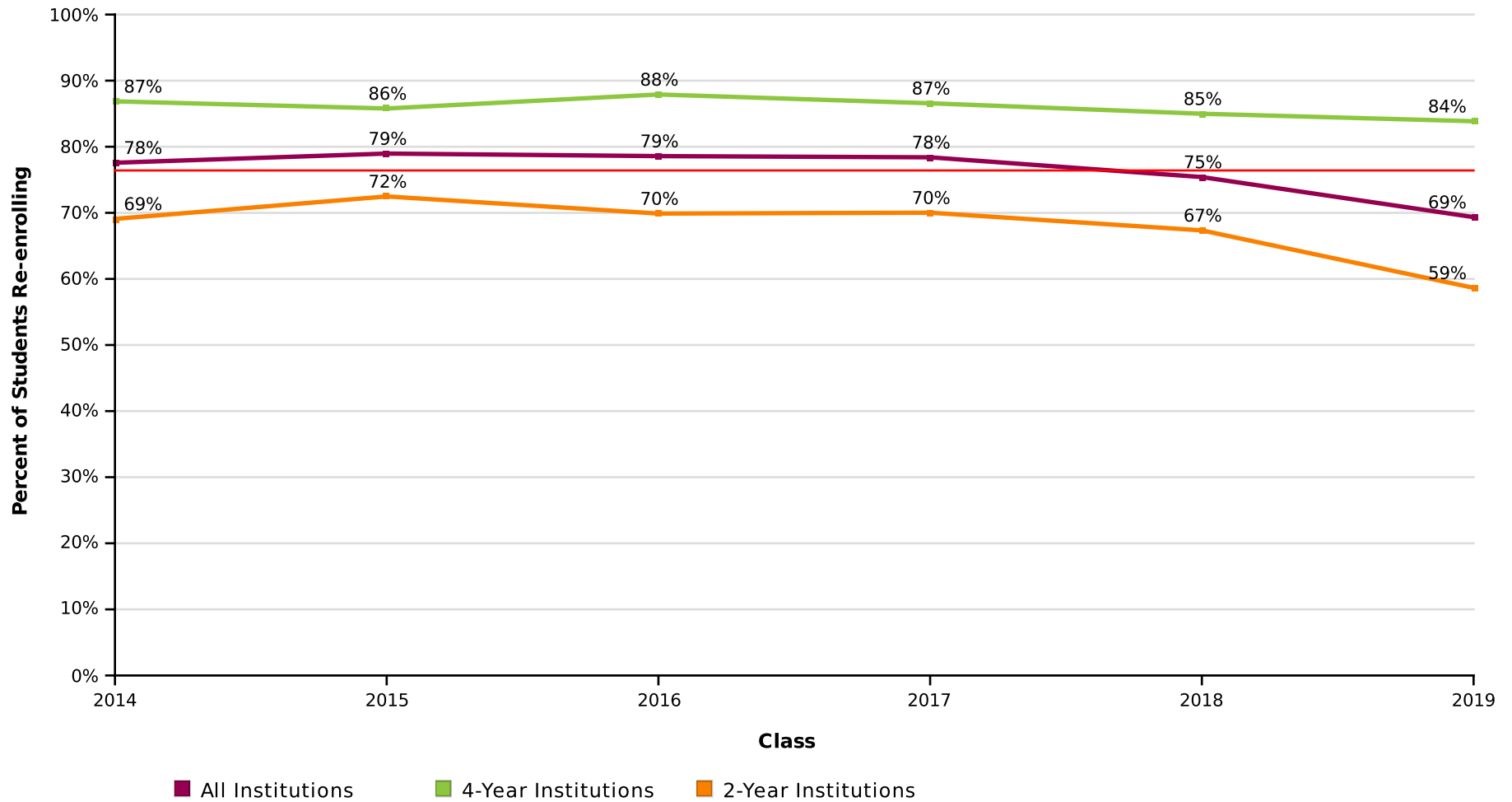

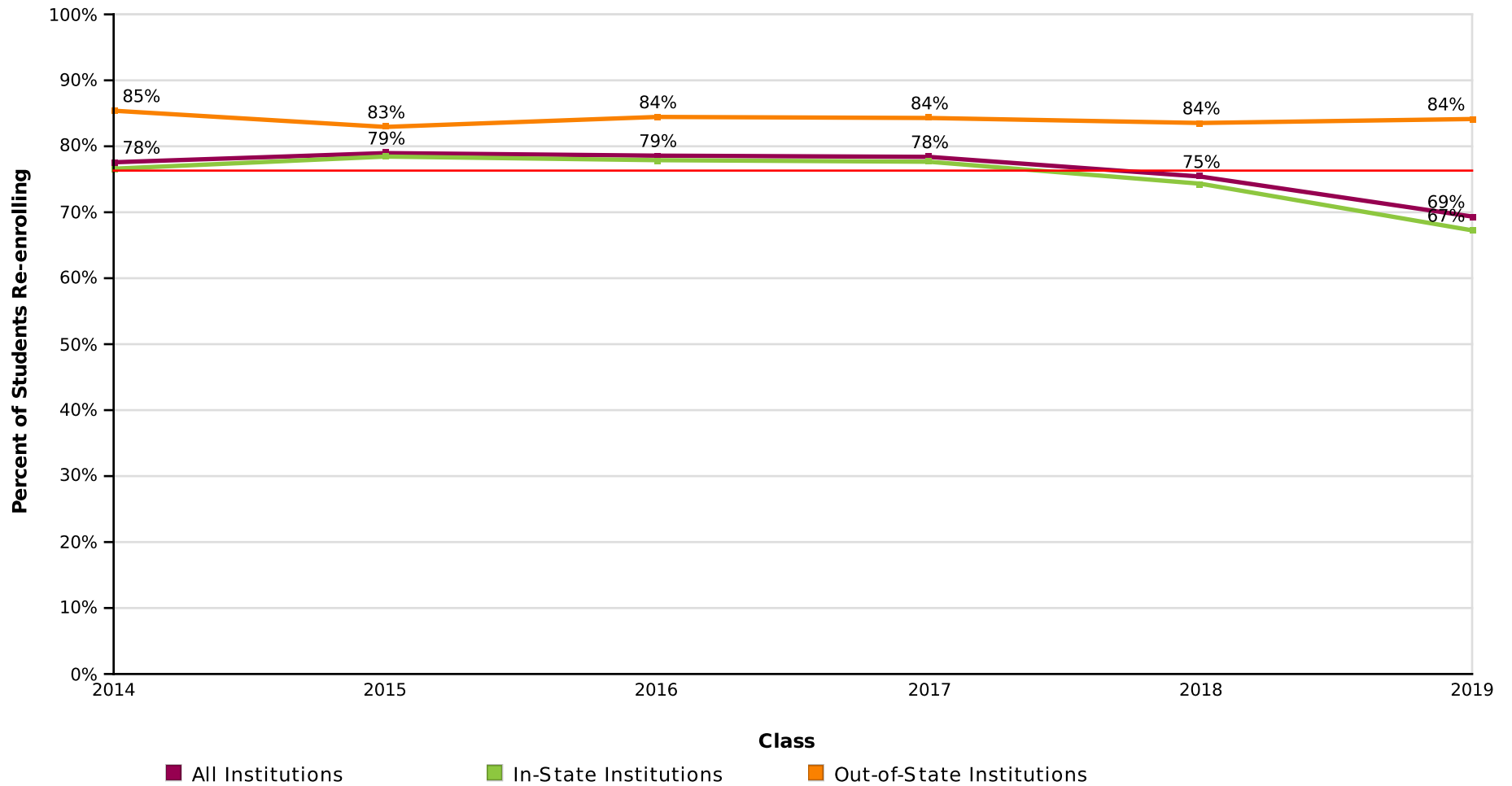

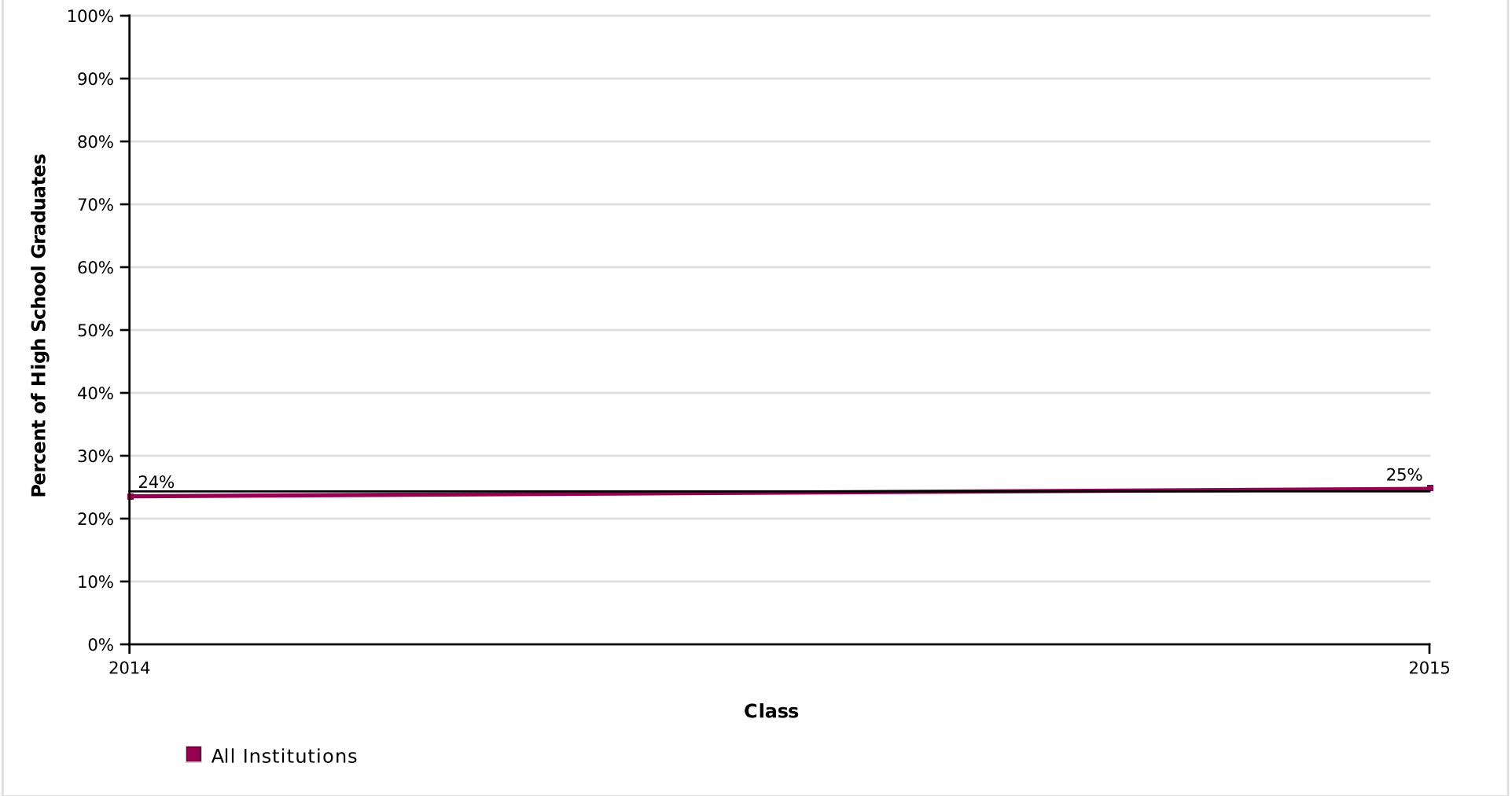

Percent of High School Class Who Completed a Degree Within Six Years

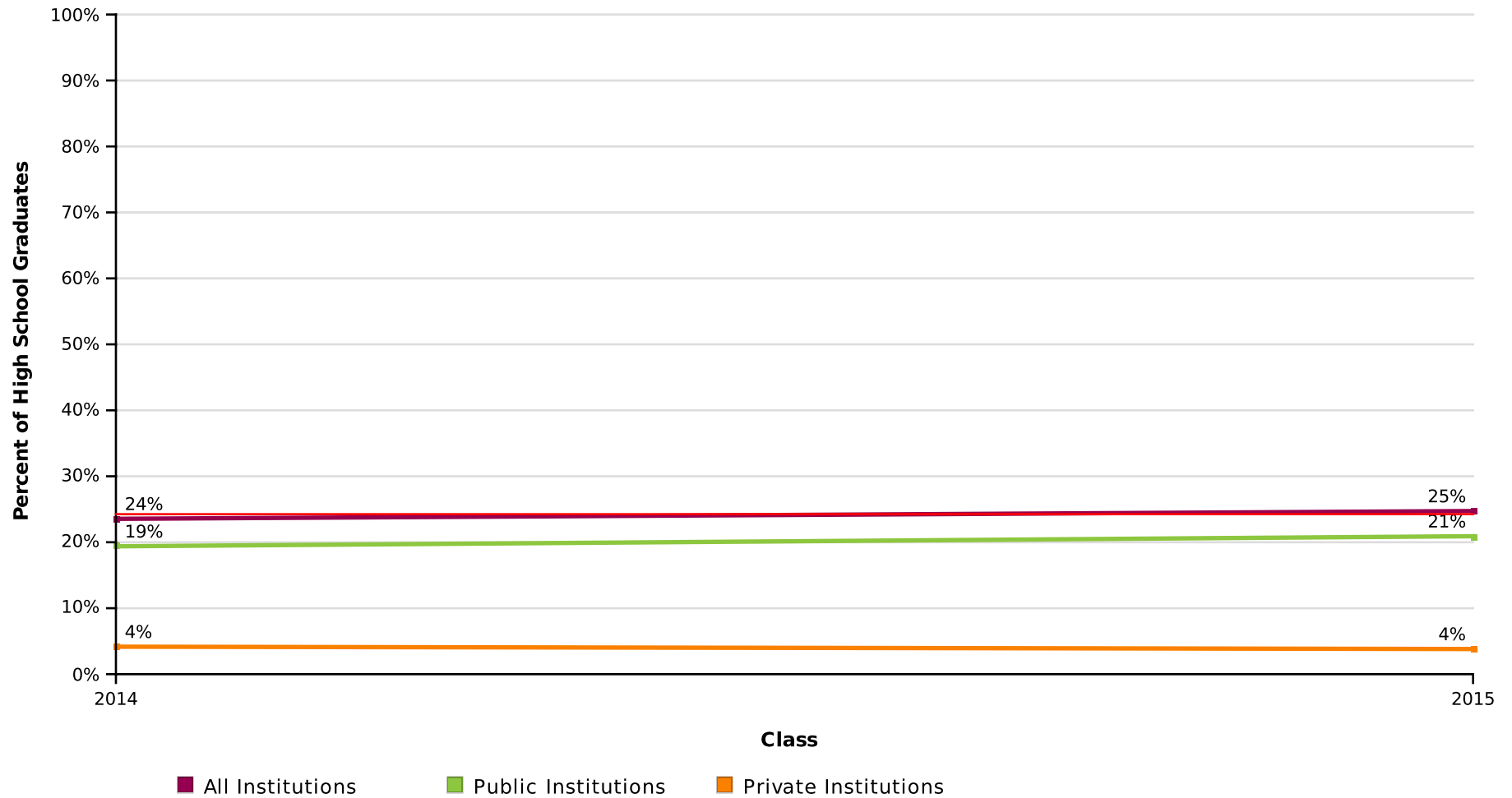

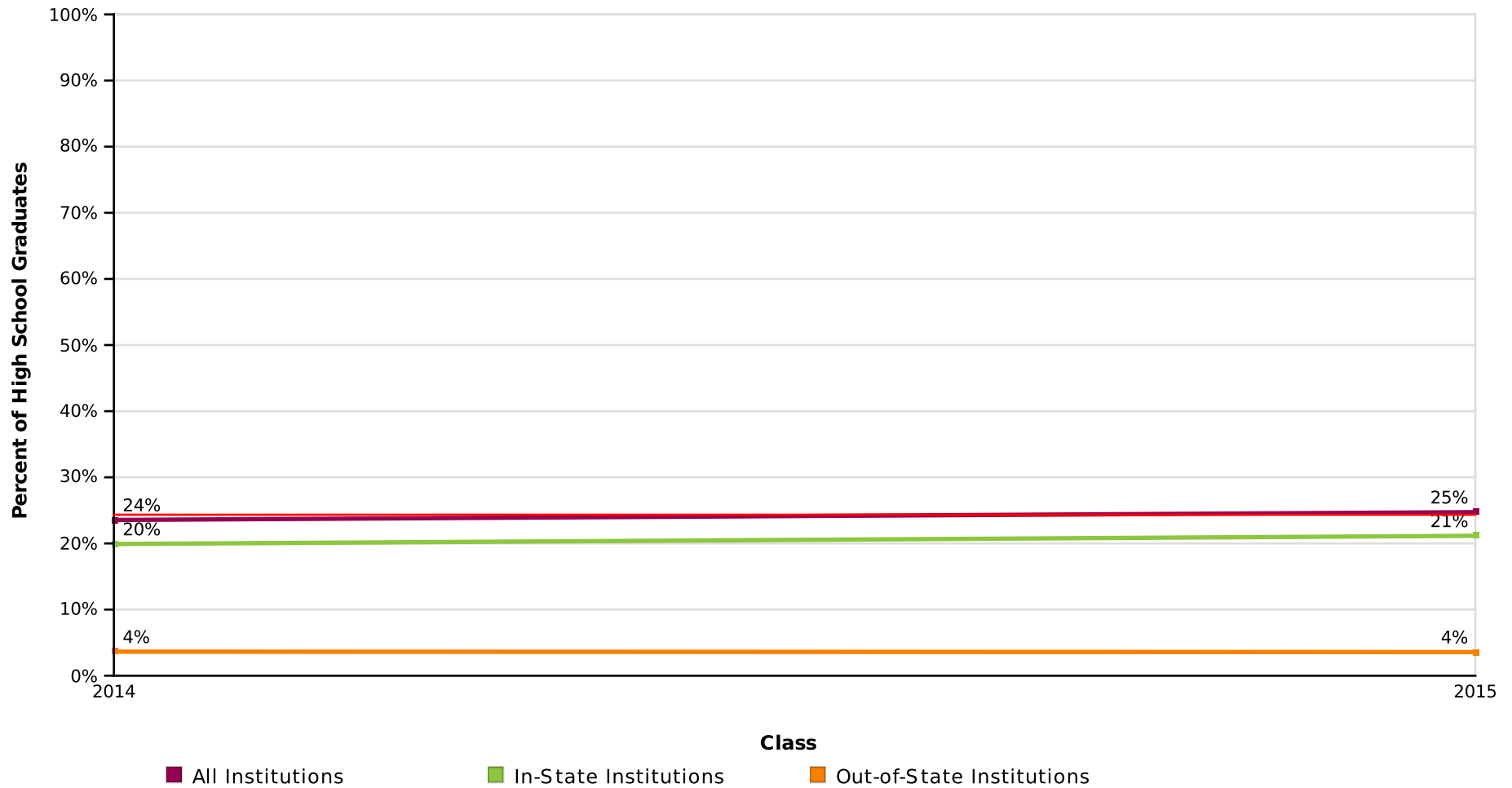

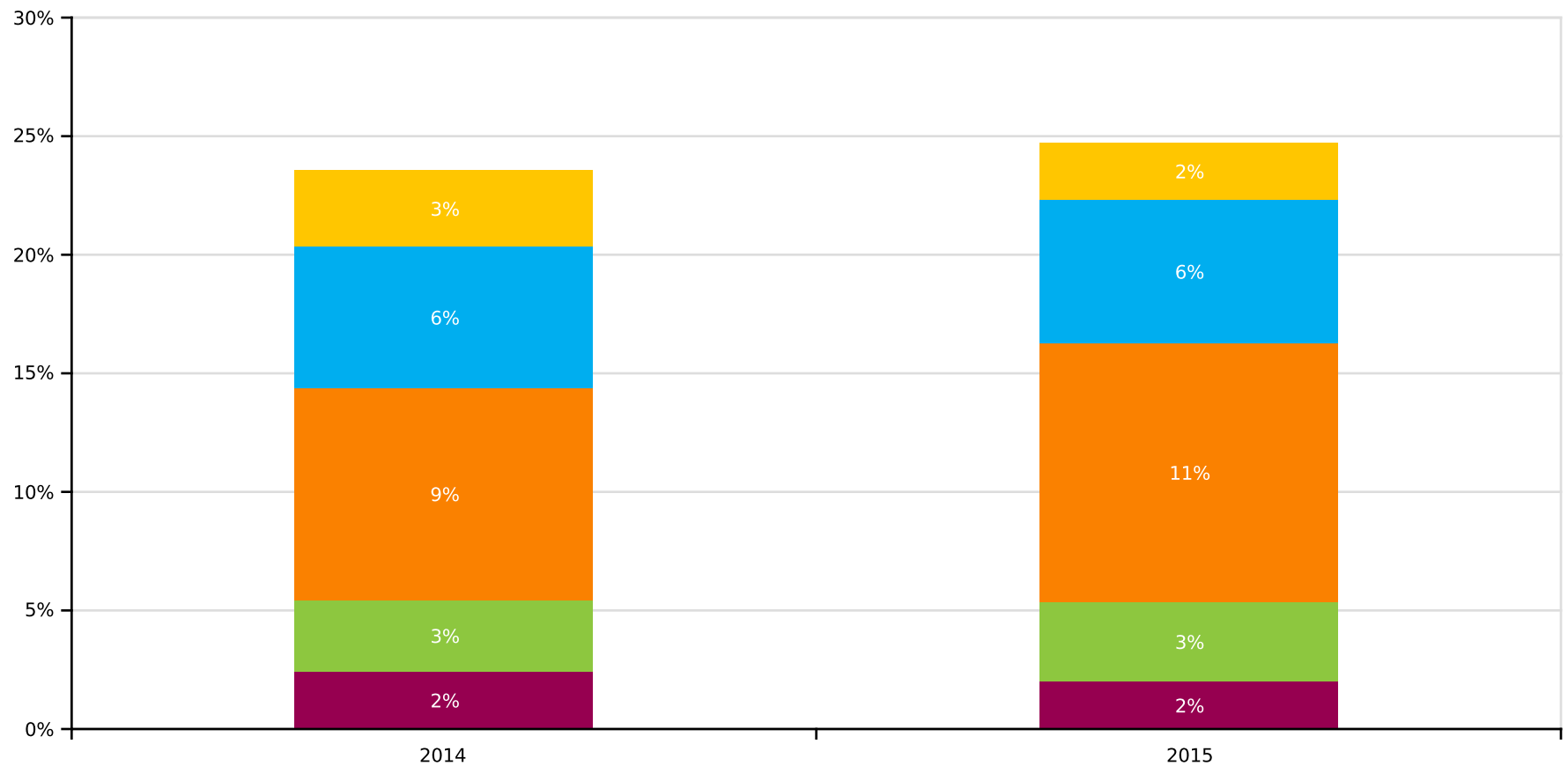

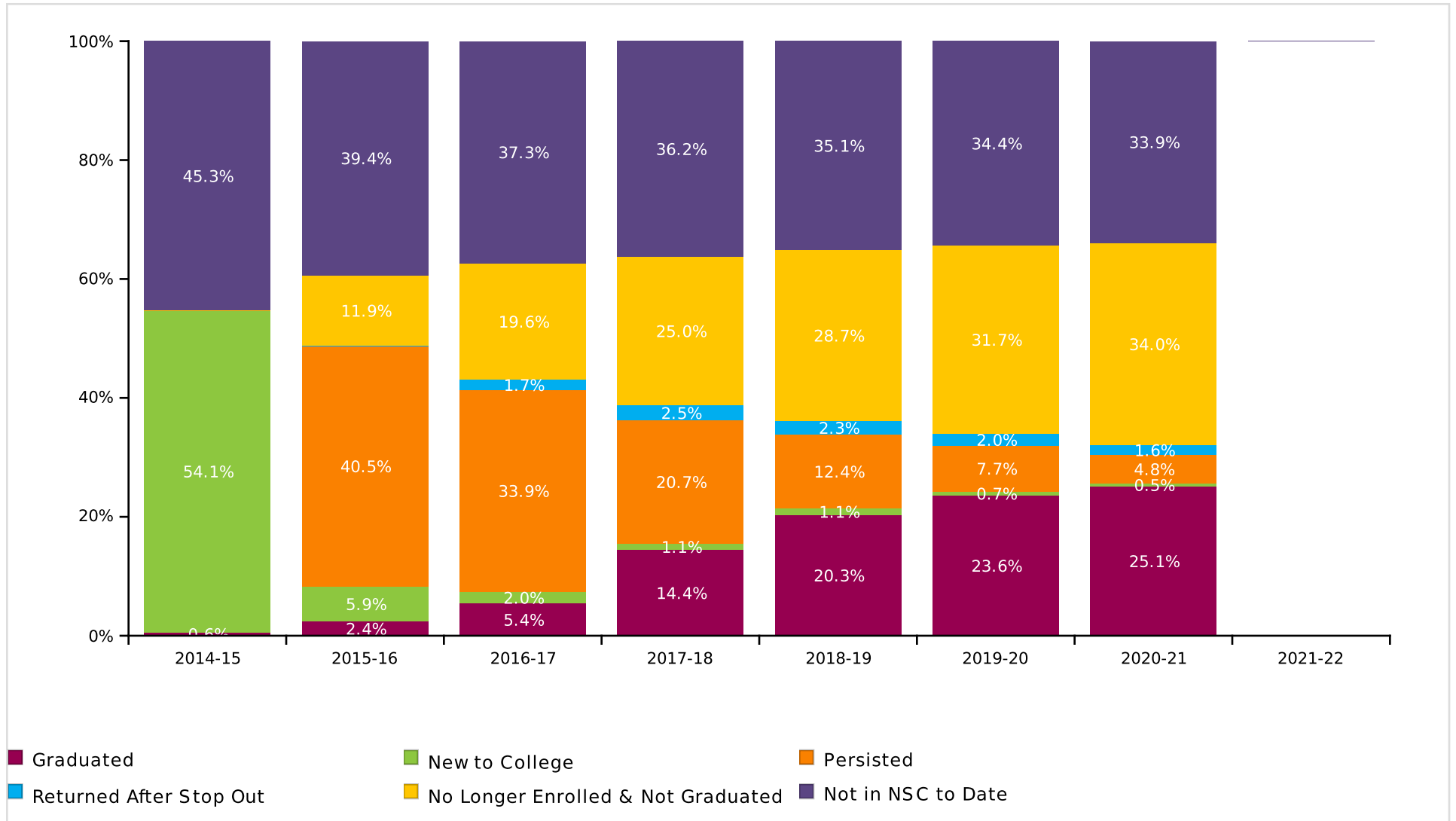

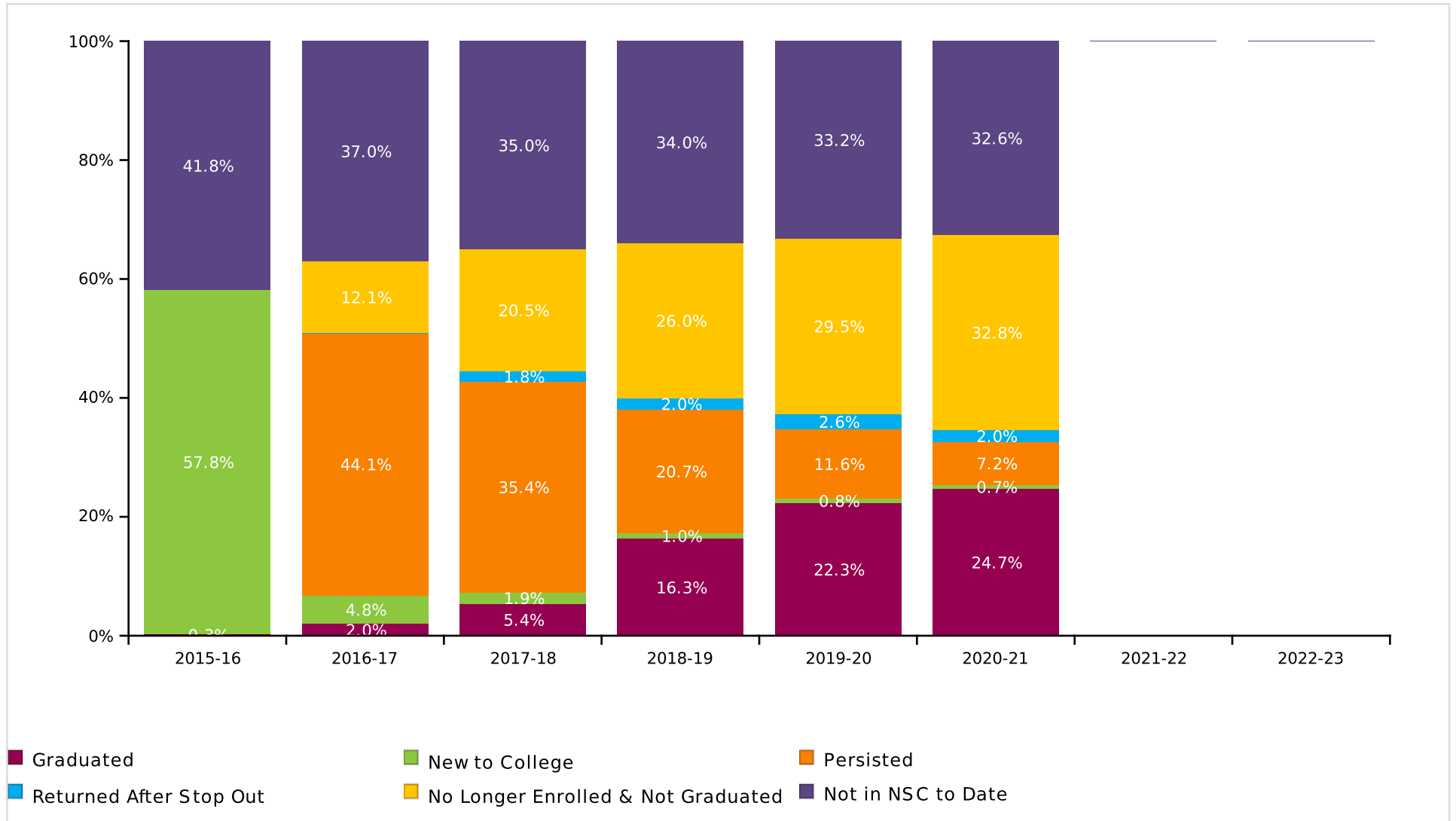

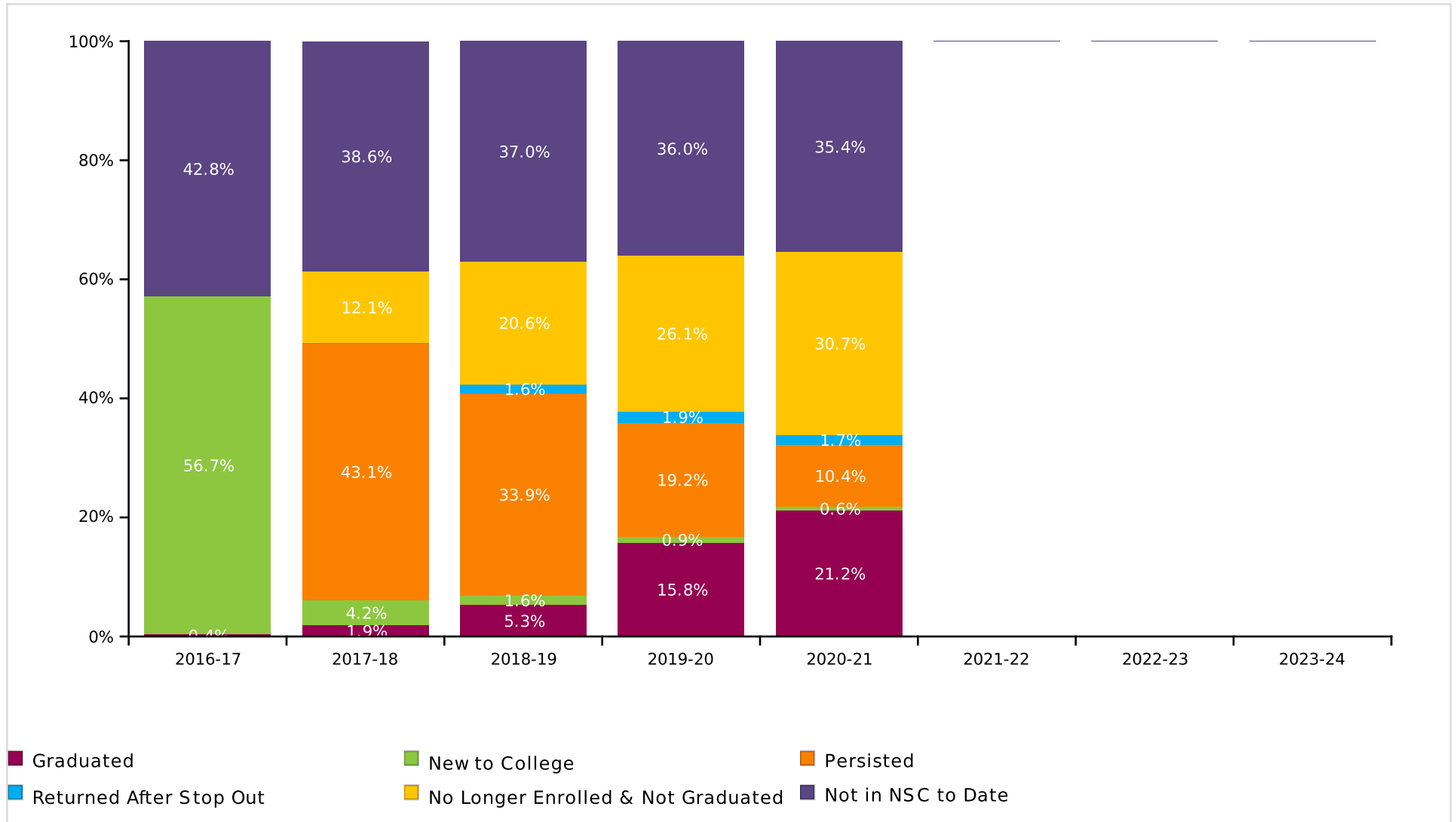

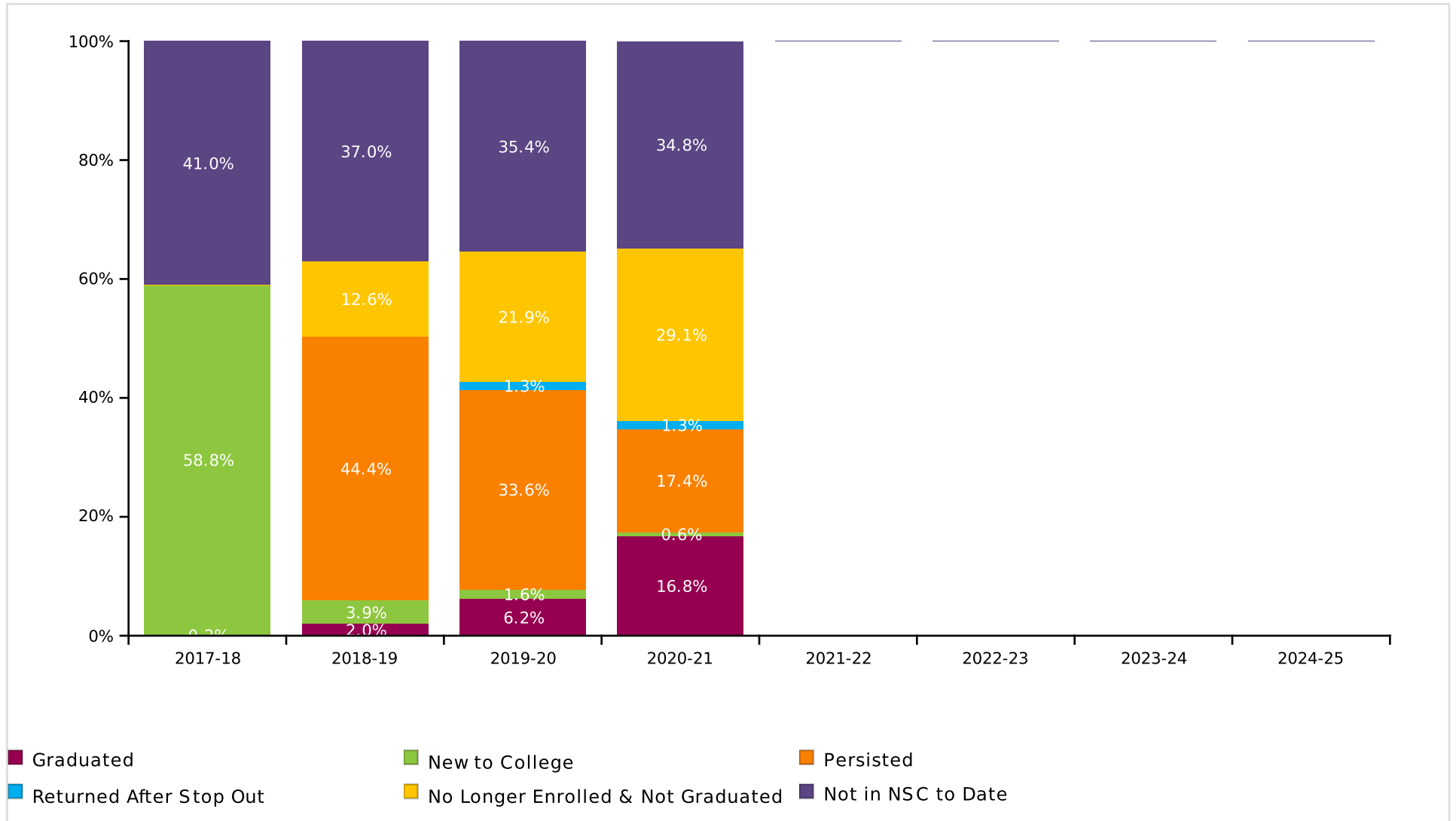

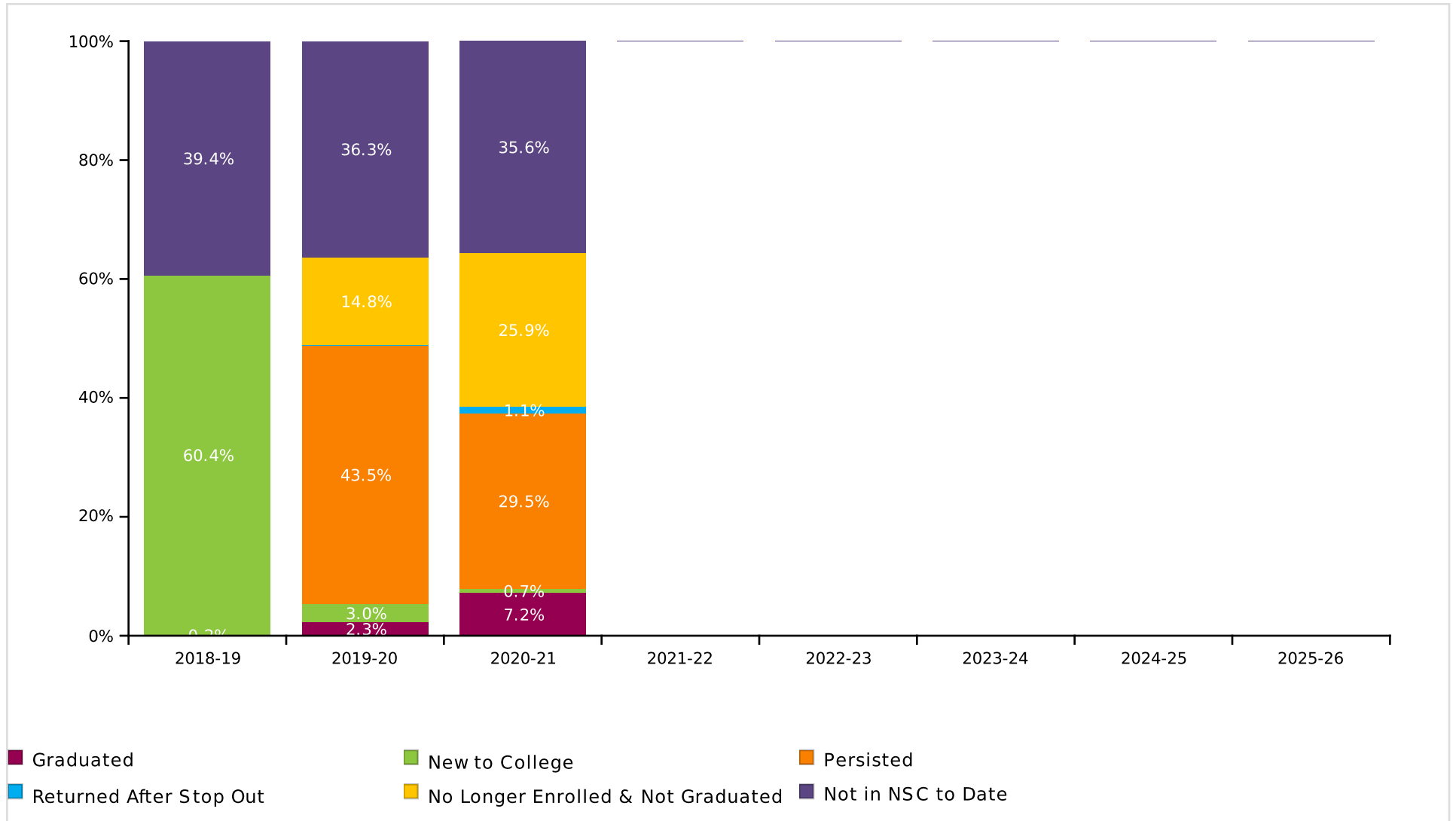

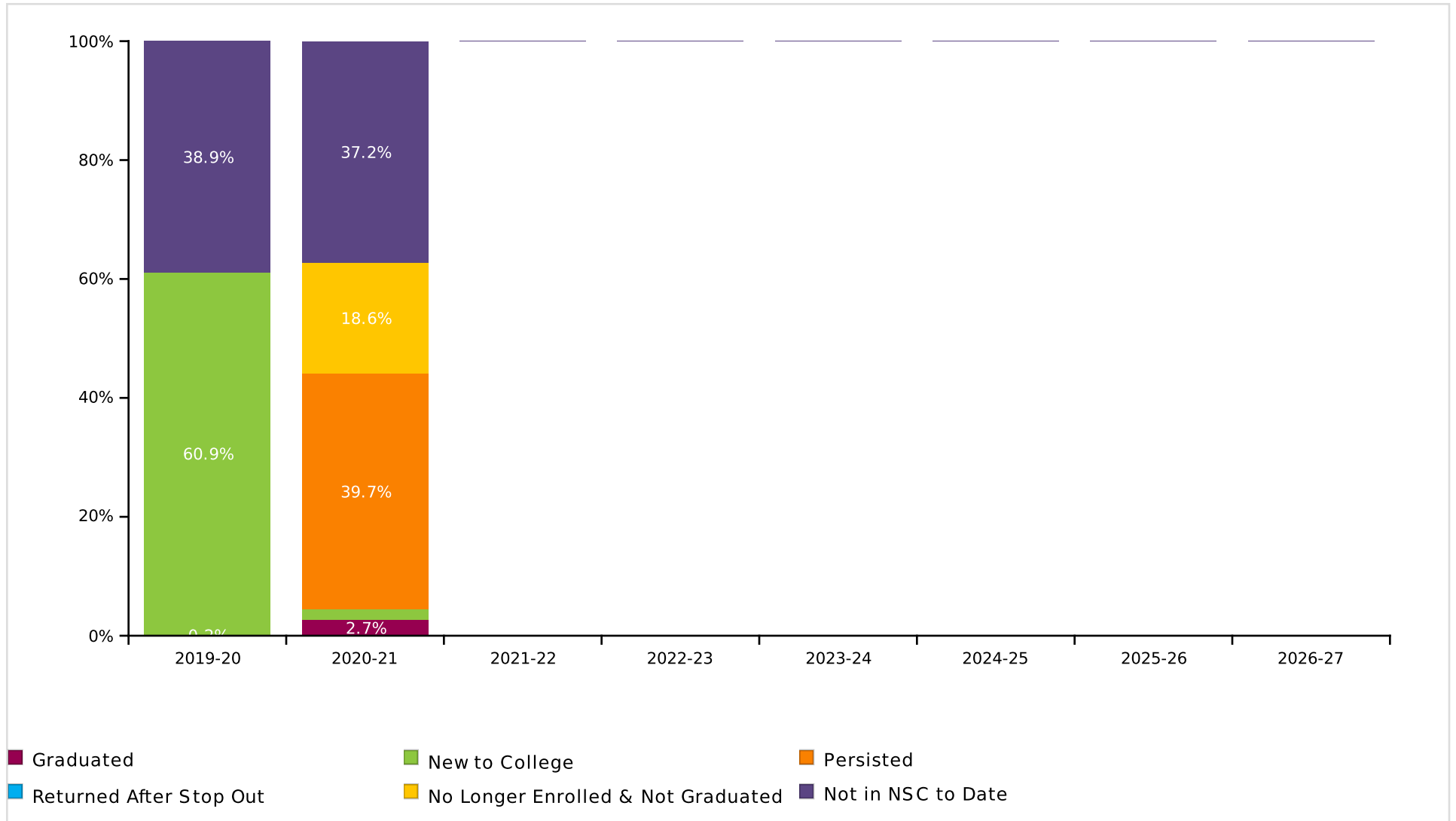

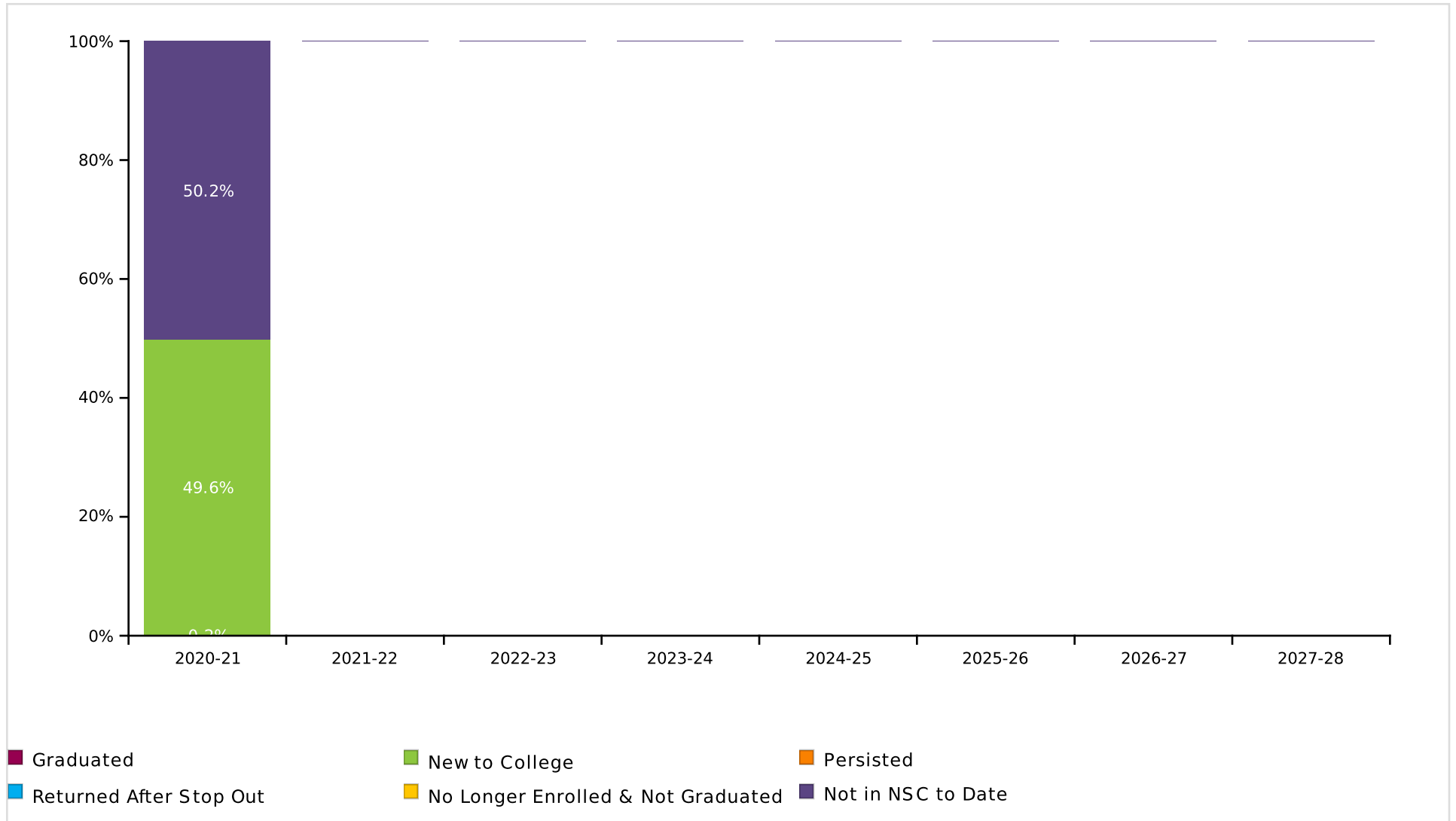
