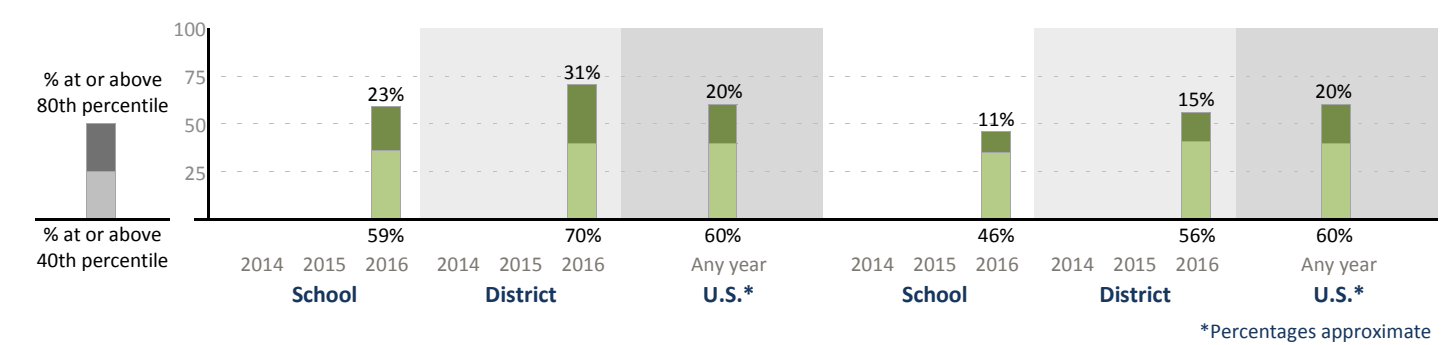

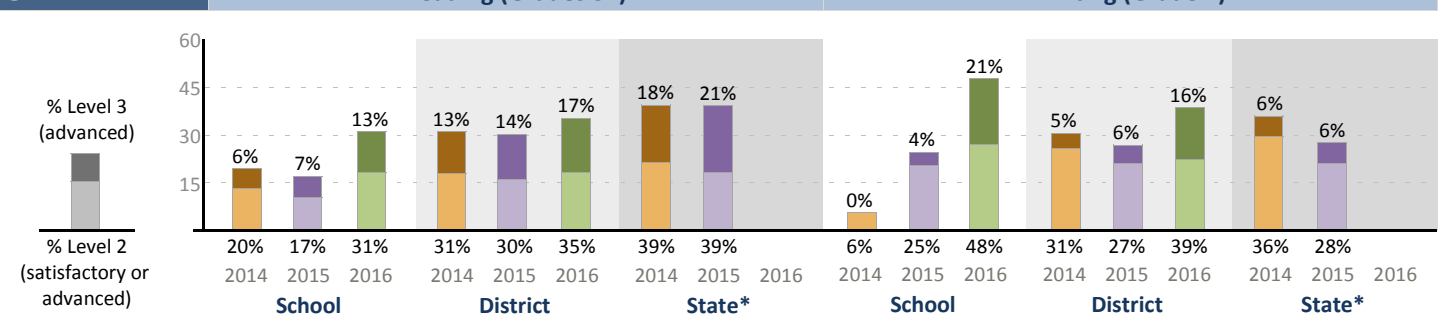
### ISIP Percentage of Students with "Kindergarten-Ready" Scores



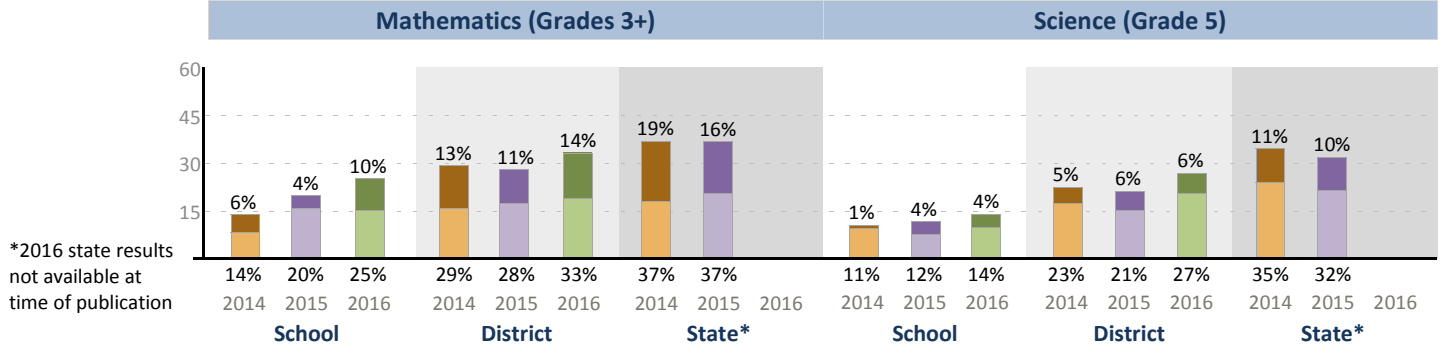
### TerraNova/SUPERA Reading Mathematics
